




INTRODUCTION



Synopsis of Taxation

Our region is speedily moving towards unprecedented reforms in economic policies by introducing taxation and its compliance. Taxation is an emerging field in the GCC region. The BIBF provides a comprehensive course for those interested in understanding the fundamentals of taxes such as Value Added Tax (VAT), Corporate Tax, Income Tax, Capital Gains Tax (CGT), Excise Tax (ET) and other duties, their working mechanisms, general principles, classification of taxes, and basic computations. The course is designed on best practices followed by renowned and the oldest Tax Regimes-based economies.

Principles of VAT

This is a comprehensive VAT course, targeting those who wish to learn about its implementational technical challenges and compliance aspects. The main topics include VAT Calculations, VAT Treatments of all Business Sectors Supplies, VAT Registration and Deregistration, VAT Reporting, Imports and Exports, VAT Invoices and Recordkeeping, and other administrative aspects.

Synopsis of International Tax Compliance

After the successful implementation of VAT in KSA, the UAE, Bahrain, and Oman, our governments are implementing other internationally-recognised tax compliance practices to minimise the misuse of gaps in different countries' tax legislation in cross-border transactions. There is no doubt that the GCC region is gearing up towards unprecedented tax reforms. The BIBF provides a well-designed course for those who want to understand the fundamentals of international tax compliance, the types of tax compliance applicable in the region, fundamental concepts, principles, and rules linked with it.

Principles of Transfer Pricing (TP)

Transfer Pricing has a significant impact and important tax compliance issue faced by multinational business entities having cross-border group transactions to address tax authorities' concerns. The BIBF offers a comprehensive course to understand the requirements and impact of TP on business entities operating in the MENA region, especially in the GCC, after the implementation of TP in KSA. The main topics include Fundamentals of TP, Associated Enterprises, the Arm's Length Principle, Comparability Analysis & Factors, Functional Analysis, Entity Characterisation, Transfer Pricing Methods, and Documentation.

Principles of Economic Substance (ES)

The Ministry of Industry, Commerce, and Tourism (MOICT) of Bahrain released detailed guidelines concerning implementing Economic Substance rules in the Kingdom of Bahrain. The Central Bank of Bahrain (CBB) has also issued a directive to all its financial institutions (licensees) for compliance with ES requirements.

The BIBF offers a comprehensive training course to understand the background of ES to handle compliance requirements of ES reporting, according to OECD, EU and published regulations by the GCC Tax Authorities. The main topics include Scope of ES, ES Tests, Reporting of ES Compliance & Administration, ES Penalties, and ES Returns. The course provides a deep comparison of Bahrain ESR with the UAE ESR.

Advanced Principles of Transfer Pricing (TP)

This is an advanced level course targeting those who want to learn more advanced technical contents of Transfer Pricing to ensure better tax management and TP compliance. The main topics include Thin Capitalisation, Advanced Pricing Arrangements, Intra Group Services, Loan and Other Financial Transactions, Intangible Properties, Business Restructuring, Permanent Establishments & Profits Allocation, Transfer Pricing Adjustments, Non-Recognition Issues, Avoiding Double Taxation and Dispute Resolution, E-commerce and Transfer Pricing, Other TP Compliance Aspects and related Issues.

Compliance of Country-by-Country Reporting (CbCR)

KSA, UAE, Oman, Qatar, and Bahrain have implemented CbCR according to the requirements of OECD BEPS Action plan 13. The BIBF offers a comprehensive training course that provides complete and most up-to-date information and skills on the compliance requirements of CbCR.

The main topics include Scope of CbCR, CbCR Notification and Return Filing Requirements, other related compliance aspects of CbCR, Nomination of Constituent Entity (CE) to file CbCR. The course provides a deep comparison of KSA, UAE, Oman, Qatar, and Bahrain CbCR compliance requirements with the OECD's published guidance.


Bahrain VAT Compliance Diploma by ATT-UK
